Anna May Nauss has served the credit union in several roles over her 35 year tenure, most notably Chief Financial Officer prior to stepping in to the President/CEO position in January 2014. A graduate of the Pennsylvania State University, Anna May is a committed community leader, serving as secretary of the Mechanicsburg Chamber of Commerce Board for several years as well as The Foundation for Enhancing Communities-Mechanicsburg Area Community Foundation Advisory Committee. An active member of the Grange since age 15, Anna May is committed to serving the community through mentorship and volunteer work. Ms. Nauss is known for her commitment to the Mechanicsburg School District, Operation Wildcat, and Project Gift Box, amongst several other local community organizations.

Over her career, Anna May has been recognized as a West Shore Chamber of Commerce Luminary Award Nominee, a finalist for the Business Woman of the Year Award through the Business Women's Forum, and a finalist for the Lifetime Achievement Award from the Conference for Women. Ms. Nauss has also provided her expertise as a speaker and panelist at local conferences and events. "Anna May not only has years of outstanding service to AmeriChoice and the credit union community, but has provided strategic leadership from our early days as an IBM Credit Union to her current position as AmeriChoice CEO," said Board Chairman, Gregg A. Wells. "Her insight and contributions have been invaluable to the Board and our staff. We want to publicly thank Anna May for her service and dedication to our members."

AmeriChoice celebrates 50 years of service to the community in 2020 and has a legacy of strong leadership. The Credit Union has seen four leaders in the top executive role, with Nauss at the helm since 2014. "It has been exciting to see the Credit Union grow and prosper over the years.
